

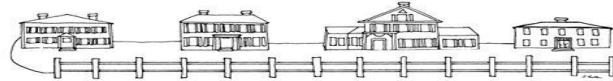

April 16, 2025

Attendance: Doug Dutile, Mike Lavoie, Albie Estes, Barb Dutile and Mary Ann Rood

Public Appearance: see attendance sheet: Chester Spruill spoke about the new basic rate and is frustrated with the increase. Mike Lavoie spoke about the water testing that is mandatory by DES. Chester stated that the water isn't drinkable. Doug Dutile explained that the testing is done daily/weekly and is mandatory. Mike and Doug explained how each resident can test their own water, if they feel it is contaminated. Doug also addressed the rate change. Mike added that we are required to provide the best water according to the state regulations. Gregory Parker asked about amount of the increase and was concerned. Doug asked, those in attendance, what can we do to make it better. Norm Frost asked if we add fluoride. Doug said that we do not add it, any fluoride is natural. Dave McKee stated that the chlorine in the water is too high. He wanted to know if everyone in the state has the same chlorine level. Both Doug and Mike stated that the levels are required by the state of New Hampshire and we have no control over the amount added. Dave had another question regarding where this conversation goes. Does it go beyond this meeting. Discussion. Mike mentioned the discussions with the other precincts and trying to coordinate a reciprocal water supply in case of contamination. Lindsey Hubbard questioned the speed limit signs. She asked if we could go to the state and have the speed reduced through the precinct instead of a flashing speed sign. She would like to put together a commission to do something about changing the speed limit. She would have to go to the Town of Haverhill. Doug spoke about the speed limit and signs. Lindsey thanked the commissioners for the work that they have done on the signs etc. She asked if it could be moved further south on DCH to include the whole town. Doug spoke about the reason for

the positioning of the speed signs. They have to be with a speed limit sign. Discussion. She asked if it could still be discussed or if a decision has been made. Doug said that it could absolutely be discussed further before we make a decision on which ones we purchase and positioning. Edward Warfield thanked the commissioners and said that he would like to get involved. Edward has a few concerns regarding the signs and the flashing lights and his additional concern is the logging trucks. He asked if the logging trucks were going to be down shifting in front of his house due to the location of the speed sign. Doug explained that we control the lights on the sign. Doug stated that there are 15 pages worth of rules for signs in the state and a lot of red tape. Doug would like to get his pricing first before any further decisions are made. Ed asked if we could have speed bumps. Doug said not on a state road. Marcia Welsh stated that she is concerned about blinking speed signs. Norm Sullivan asked if we were talking about the flashing sign and if we were, he stated that it only flashes on one side. Discussion.

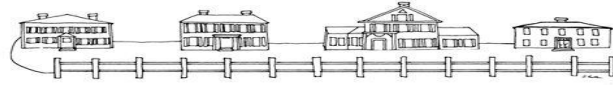
Approve Prior meeting minutes: Motion to approve by Mike Lavoie. Second by Doug Dutile – all in favor
