Approve Manifest: Reviewed and signed by commissioners


Old Business

Bob Long (Mountain Lakes): Doug Dutil discussed the fact that Bob came to discuss administrator options going forward and the possibility of sharing one. Both Mountain Lakes and Haverhill Corner need to do more research before any further discussion.

Review liens to be signed: Motion by Doug Dutil to sign liens and send the check to the Registry of Deeds. Second by Mike Lavoie – all in favor

Other Business:

Doug Dutil spoke with Dan Boutin August 19th. They discussed issues with the two wells that were discovered last year. They have been renumbered to coincide with Woodsville's map. There are two top tiles broken without flanges and a broken cover on one. They also discovered missing markers (all of them) and cannot locate the blow-offs. Dan has to re-mark the line. The Underhill property that was logged is where all flag markings are missing. Doug asked if there is an easement because we need to make the realtor aware that there is an easement. Doug would like us to get copies of the deeds to properties where we have easements. Discussion.

Doug Dutil asked Albie Estes if he checked with Russ Priestly about having a new sign made for the Fire Station. He did phone, but needs to follow-up.

Doug Dutil was brain storming – he thinks we should invite two selectmen from the town of Haverhill, out to look at the driveway. He heard that the town is looking for a cooling station/emergency shelter. He would like to propose this building and then ask them to help with the driveway. Discussion. He asked the other commissioners to think about it. Mike Lavoie said that we would need to determine who would be in charge.
