Old Business

Speed Sign update: Doug Dutille met with the police chief. Additionally, Doug spoke with the DOT and they gave him a form that has to be filled out. Everything appears to be moving forward. Discussion.

New water meter installation update: Doug Dutille met with Kevin (WW&L) today. It seems to be going well. We have 30 meter left to install. Doug and Mike Lavoie plan to tag residents who have not responded. Kevin and Doug discussed the larger meters require at a few residents. We should go through Harold for equipment as he has a new distributor. Discussion

Justin Tice's nomination to planning board: Doug Dutille asked Justin if he is working or planning to go to school. He plans to go to school next fall. Doug asked his age as there is a requirement. He is 18, which means he is legally able to serve on the board. Doug wanted to ensure that he was available for the meetings. Motion by Doug Dutille to be approve Justin for planning board. Second by Albie Estes – all in favor. Barb Dutille did the swearing in of Justin to the planning board.

New Business

Treasurer's report: Presented by Barb Dutille. Unanticipated Funds \$28,691.77 / Water Account \$33,965.87 / Donations \$3,167.91 / Building Account \$135,126.62. Motion to accept as stated by Doug Dutille. Second by Albie Estes – all in favor. Bar Harbor Health – Motion to approve by Doug, Second by Albie Estes – all in favor

Petty Cash: Planning board needs access to funds for mailing certified mailings. They can present a total of the expense and we can provide a check or they can bring the envelopes to the precinct and we can mail them. We do not want petty cash here per auditors.

Unhappy Customer: Doug Dutille called the customer and discussed his comments on his most recent invoice. Doug told him that he was welcome to run for commissioner and help out. Doug invited him to our meeting, but he didn't show.

Daniel Conlin's water meter: Discussion about an oversized meter. Harold (WW&L) sent his guys to Conlin's house. Harold told Doug Dutille the easiest way to convert his meter. The home owner will keep the meter he installed. Discussion

Other Business: DRA M-535 needs approval. Motion to approve the draft with Albie's recommendation by Doug Dutille. Second by Albie Estes – all in favor Doug read a note from Jan (Better Bookkeeping). She described her experience with Mary Ann Rood and complimented her in her ability to convert via phone (saving the precinct several hundred dollars)

Dan Boutin cleaned the wells. Dan called Doug Dutille to inform him that he found two more wells. He suggested that we have Woodsville print out the map so that we could compare. Woodsville went and checked it out. They brush hogged around and opened the well (s) and they were clean. Albie Estes suggested they could actually be the test wells when they were looking for more water. The wells were put on the map, GPS'd, and a revision was submitted to the state. Additionally, a second waiver form was sent to the state.
