New Business:

Treasury report: Update given by Barb Dutile regarding balances. Water dept. \$55,924.45 / Now Checking \$48,215.48 / Donations \$3,164.55 / Building Acct. \$93,063.79 – Mike Lavoie would like to introduce during the upcoming public budget meeting, the water account, with possible options on how to spend the

funds. Commissioners to come up with ideas to present. Barb Dutile to find out exactly how we came about the money.

Past due water accounts: discussed and reviewed the tagged list.

Water bill complaints: Miles Conklin was missing his farm water rate – corrected.

Discussion about whether the town is responsible for additional fees on property they took over at 546 DCH – Doug Dutile will check with town.

Water billing: Mary Ann Rood to reach out to Pete with Ti Sales regarding meter readers.

Other Business:

Budget reviewed for upcoming new budget. Mary Ann Rood to call USDA to find out balances.

Should we install an alarm system for the monitor building. Mike Lavoie suggested that this should be covered in the pre-budget session
