Approve Agenda: Motion to approve by Albie Estes. Second by Doug Dutile – all in favor

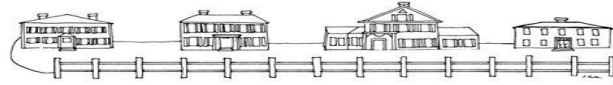
