Old Business

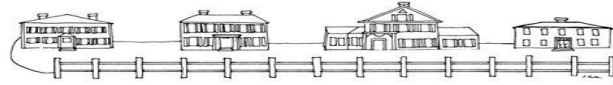

J&A Lawncare: Doug Dutile said that he understands that the weather has not cooperated with lawncare this season; however, we received two invoices, one for cleanup and one for mowing (May, June, July) from J&A – Doug motioned to pay the cleanup bill for \$175.00. Second by Albie Estes – all in favor. Second bill for \$975.00 (May, June, July) mowing. Doug motioned to table the bill because they have only mowed once and would like to speak with the owner. Albie Estes stated that the original contract was broken down by weeks instead of three-month blocks. Second by Albie Estes – all in favor. Discussion: Jack Hubbard asked if the broken asphalt could be picked up by J&A. It was suggested that the DOT could take it away due to its toxicity.

Other Business: Barb Dutile commented on the new sign (sandwich board) at the end of the driveway– she thanked the administrator for the idea. Barb and Doug put it together (filling it with sand) and placed it at the end of the driveway.

Doug Dutile has all the information for the radar signs. He mentioned that he has a vendor list for the signs and he will see what we can come up with. We have the money to purchase through the approved warrant article.
