Approve Prior meeting minutes: Motion to approve by Mike Lavoie. Second by Albie Estes – all in favor


Approve Manifest: Reviewed by commissioners and signed

## New Business

Treasurer's report: Presented by Barb Dutile. Unanticipated Funds \$28,769.81 / Water Acct. \$40,241.77 / Donations \$3,169.64 / Precinct Acct. \$76,517.07 / Debit Card Acct. \$1,252.27.

Mike Lavoie motioned to approve as printed and read. Second by Albie Estes – all in favor

Customer's late fees: Administrator discussed customers not paying the late fees on overdue invoices. Mike Lavoie made a motion to authorize Mary Ann to send out a copy of regulations with highlighted late fees and must be paid withing 30 days. Second by Doug Dutile. Administrator will confirm regulations, discussion – all in favor

Water Lines: Doug Dutile discussed the fact that Dan Boutin couldn't locate the water line on the Underhill property. We hired WW&L to locate the line and install the markers. They found the old class 6 road and under it was all washed out. Approx 20 feet of our line is exposed. Harold phoned Doug telling him that they found another 20 feet of exposed water line up near the water box. We have 40 feet of water line that needs to be covered before winter. Doug reached out to Eddie Paige and he will work with WW&L to get the line repaired and covered before winter. The water line that comes across the Underhill property needed an easement. We need to locate said easement. Discussion.

Other Business: Mike Lavoie discussed the flag on the common and the end of the driveway – the fact that no one lowered the flag half-staff for 911, so he did it. The flag on the common was so bad it had to be replaced. Barb Dutile purchased a new flag for the triangle. He wants to know who is responsible for the flags. Discussion
