Old Business

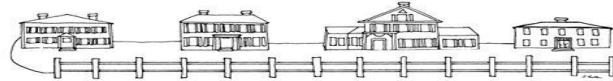
New sign for Fire Station: Albie Estes stated that as soon as Russell finishes two other signs, he will start on ours
